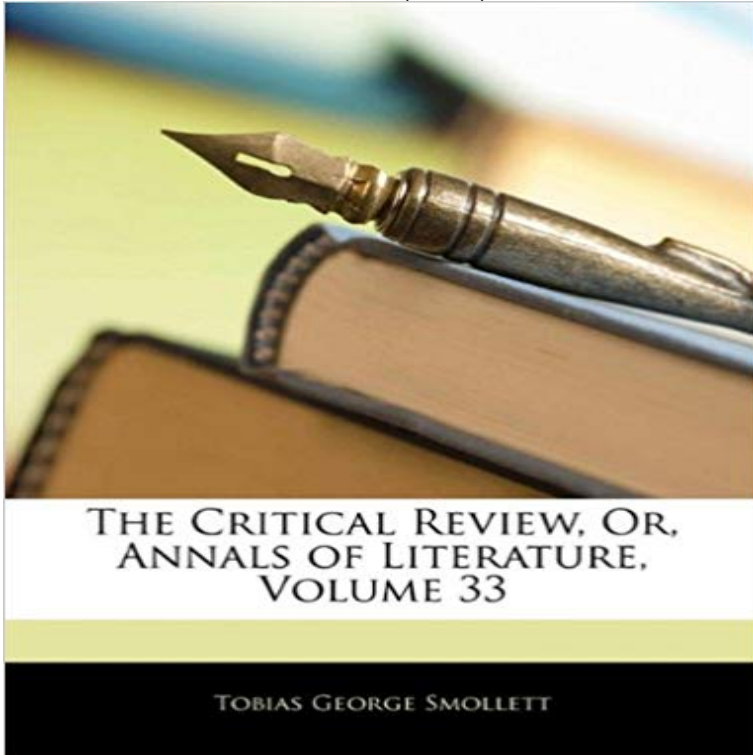


# The Critical Review, Or, Annals of Literature, Volume 33
